Registrar Report:

- A new child has inquired about registering into Peewee House for January.
 - According to my interpretation of the registration policy (see below), the fees should be prorated based on the number of months missed.
 - The treasurer deferred the calculations of fees to either myself or the President
 - I have calculated the fees as follows:
 Egiptive First a remaining months where 7 represents the # of months of allocated ice (Sept March)
 - o In this case, the fee will be \$278.57 (based on \$650 annual registration fee for Jan-Mar).
 - Registration policy #13: "Unless new to DRAMHA, no player shall receive a reduced fee if they register late. If a new player moves to DRAMHA's jurisdiction and registers after October 31 the fee will be pro-rated based on the number of months missed. Prior to October 31 the full fee applies."

Goalie Clinic: Assistant coaches/aides

- I've contacted the District Registrar and have been instructed as follows:
 - o ALL persons on the ice must be on a team.
 - If we place them on an IP team, they must be designated as an assistant coach and have the corresponding courses/clinics for IP
 - If we place them on a Novice-Midget team, they can be designated as an On Ice
 Volunteer and would require only Respect in Sports for Activity Leaders and Gender Identity Training.
 - On Ice Volunteers can not coach in any capacity. They are designated as AIDES
 and can not be involved in coaching, teaching or instructing goalies. Their roles
 are to assist the coaches with "Player and equipment movement and other
 related activates"
